TERMS AND CONDITIONS

CONTRACT:

Your contract is with Jonathan Brier Yachting. When you sign the booking form and make the deposit payment, you are accepting these conditions. The booking agreement becomes binding when signed by you and confirmed in writing or email by Jonathan Brier Yachting. Deposits are non-refundable.

BOOKING:

Please telephone 01425 622502/07905 371181 to confirm availability, then complete all sections of the Booking Form. A booking is secured when made in writing on the form overleaf and accompanied with a 25% deposit. Telephone or email bookings will be held for 7 days from dispatch of the booking form and confirmed on receipt of the outstanding balance. All bookings will be confirmed in writing by the issue of your booking confirmation and joining instructions. Payment in full must be received and cleared by our bank 6 weeks prior to the start of the Course/Cruise/Event. Bookings made within 6 weeks are to be paid in full at the time of booking. Relevant parts of page 1 must be completed by all participants at time of booking.

No guarantee is made as to destinations and/or timings due to the nature of sailing and no liability is accepted for additional expenses incurred. No animals, plants, restricted items or illegal goods must be brought on board the yacht. Any individual who compromises this will be in breach of contract, and may be requested to leave the vessel.

In order to maintain a high standard of instruction, the maximum number of students on any RYA course will be five. As part of the experience of cruising on a sailing vessel, you will be expected to share domestic duties during the Course/Cruise, including cooking, washing up and cleaning. At the end of a Course/Cruise/Event, clients are expected to leave the yacht in the condition in which it was found. Please inform us of any special dietary requirements.

AGE LIMITS:

Jonathan Brier Yachting cannot accept clients under the age of 18 unless accompanied by a Parent or Legal Guardian.

CANCELLATION:

If Jonathan Brier Yachting has to cancel the booking due to circumstances beyond its control, then alternative dates will be offered or a full refund of fees already paid. No liability will be accepted by Jonathan Brier Yachting for incidental expenses incurred in the event of cancellation, the yacht being unable to return to port, or any other agreed destination on time due to weather, engine breakdown or any other circumstances. Clients may elect to stay with the yacht at no extra charge, or make alternate arrangements to return at their own expense.

If you have to cancel a confirmed booking, this must be made in writing (email is acceptable) at the earliest opportunity and is deemed to take effect upon receipt. Clients will be liable for the full course fee if a booking is cancelled within 6 weeks of the start of the course/cruise/event. No refund or part refund can be given if clients leave the yacht prior to completion.

INSURANCE:

The Yacht provided by Jonathan Brier Yachting conforms to the Department of Transport's Code of Practice for Small Commercial Vessels. It is fully insured against accident, third party liability and personal injury arising from negligence by Jonathan Brier Yachting. However, Jonathan Brier Yachting accepts no liability for personal accident or loss or damage to the property of the client. Clients participate in any activities at their own risk and are advised to take out the appropriate holiday insurance to cover these eventualities and cancellation charges.

INSTRUCTORS/SKIPPERS AUTHORITY:

Decisions made by the Instructor/Skipper are final in respect of the safety of the vessel and the welfare of the crew.

HEALTH AND SAFETY:

Sailing is an activity sport and is the responsibility of client to ensure they are fit and healthy to sail. Please check with your GP if in any doubt whatsoever. If you are taking any medication please bring double the amount so that you carry your usual dose and the Instructor/Skipper can hold a reserve in case of emergency.

COMPLAINTS:

Should you have a reason to make a complaint, please make it known to the on board Instructor/Skipper at the earliest possible time. We would like the opportunity to deal with any issues as they arise so we can rectify them immediately. Should you then feel that your issue was not dealt with satisfactorily please contact the Principal, Jonathan Brier, again at the earliest opportunity and in writing, to be received within 28 days.
